## 2025 CLARIFICATIONS



#### PROPERLY WORN CHINSTRAPS

A protective helmet, designed for lacrosse, which met the NOCSAE standard at the time of manufacture and has a visible, exterior warning label regarding the risk of injury. The chinstrap shall be worn <u>on</u> the chin and shall be firmly attached at all the helmet's manufactured attachment points, securely enough so that the helmet is unable to be removed without detaching the chinstrap from the attachment point(s). All helmet decals and external markings shall be school-issued. All players of a team shall wear helmets of the same color or colors



### GOALKEEPER EQUIPMENT ISSUES

ART. 1 Ten players shall constitute a full team and shall be designated as follows: Goalkeeper, Defense, Midfield, Attack. A team shall begin the game with at least 10 players, and must have a legally equipped goalkeeper on the field at all times, or it forfeits the game.

2.1.1 SITUATION: Goalkeeper B1 leaves the game due to an injury, <u>equipment issue</u>, expulsion or penalty. Team B refuses to send in another player to play that position. RULING: Team B must put a legally equipped goalkeeper on the field or it forfeits the game. The official will allow a full one-minute delay for replacing the goalkeeper on the field beginning with the replacement's warm-up.



#### POSSESSION ON FACEOFF FOULS

#### ART. 1

Play shall be started at the beginning of each period and after each goal by facing the ball at the Center.

#### **EXCEPTIONS:**

- 1. When a period ends with a player-advantage situation or a flag-down creating a player advantage, the next period starts by awarding the ball to the team in possession or entitled to possession at the same relative position on the field. Players are not confined behind the defensive-area lines on the restart.
- 2. When a player or team commits a foul before the faceoff, the ball will be awarded to the offended team in its offensive side of the field at center. Players are not confined behind the defensive-area lines on the restart.
- 3. When a player delays resumption of play by any action after "down," the ball will be awarded to the offended team in its offensive side of the field at center. Players remain confined behind the defensive area-lines until the whistle restarting play.
- 4. When a player moves his crosse or any part of his body after "set," gaining an advantage, the ball will be awarded to the offended team in its offensive side of the field at center. Players remain confined behind the defensive area-lines until the whistle restarting play.



#### **CHECKING WITH THE CROSSE**

- ART. 1... A player may check an opponent's crosse with their own crosse when the opponent:
  - a. has possession of the ball;
  - b. is within 5 yards of a loose ball; or
  - c. is within 5 yards of a ball in flight.



#### RESTARTS NEAR TABLE AREA

ART. 4... Any restart within the confines of the table area, or within five yards on either side of the table area, shall be moved five yards into the field from the sideline.





# LOST EQUIPMENT IN SCRIMMAGE AREA

ART. 7 . . . Play shall be suspended immediately if a player loses any mandatory equipment while in the scrimmage area. If that player's team is in possession or entitled to possession, that team will be awarded possession on the restart. If the ball is loose outside the crease, the ball will be awarded using the alternate-possession rule. If the ball is loose inside the crease, award the ball to the defensive team. If a player outside of the scrimmage area and not in possession of the ball loses mandatory equipment in a legal way and no other players are in the immediate vicinity, then the play may continue. A loss of equipment during the play of the game triggers an official's time-out and should not be confused with a player entering the game without some item(s) of mandatory equipment which is a foul.



### INDIRECT/UNINTENTIONAL CONTACT

ART. 2 . . . A player shall not make indirect contact to an opponent's head and/ or neck. Indirect contact occurs when the initial force of the contact is to the body of the opponent then slides up to the head and/or neck area.

PENALTY: A one-minute non-releasable foul. An excessively violent violation or an intentional slide up to the head and neck area may result in a longer non-releasable penalty or an ejection.



## **SLOW-WHISTLE TECHNIQUE**

- ART. 3 . . . The slow whistle shall be used when:
  - a. A foul is committed against the player in possession of the ball or some other member of the attacking team.
  - b. A personal foul is committed against the team last in possession during a shot or pass.



#### **INADVERTENT WHISTLES**

#### ART. 3

Inadvertent Whistles – In the event of an inadvertent whistle, play shall be suspended immediately. The team with possession or entitled to possession when the whistle was blown shall retain possession. If the ball was loose outside the crease, possession shall be awarded by alternate possession. If the ball was loose inside the crease, award to the defensive team. If the inadvertent whistle occurs prior to the ending of a faceoff, reface




## 2025 POINTS OF EMPHASIS



#### **EYE SHADE**

- Eyeshade (grease or non-glare strips/stickers) must be a solid stroke with no words, numbers, logos, or symbols.
- Eyeshade extending beyond the eye socket or below the cheekbone is prohibited.
- Violation of the eyeshade rule (1-10-1h) results in a one-minute non-releasable personal foul for illegal equipment
- Officials should check for eyeshade violations and address potential issue before the game begins.





## PROPERLY WORN EQUIPMENT

- Chinstrap must be worn on the chin and securely attached at all helmet attachment points. Helmet should not be removable without detaching the chinstrap.
- Rule 5-6: Use of non-conforming equipment is prohibited and penalties for illegal equipment is a non-releasable foul.
- New wording clarifies that chinstraps are intended to be worn securely on the chin, not under it.






#### SCRIMMAGE AREA

• The scrimmage area is the area that is roughly within five yards in all directions of the ball or part of active play. The player in possession of the ball is always in the scrimmage area.



## **NEW FIELD DIAGRAM**

- New field diagram clearly defines the Coaches Area and Team Area.
- Expanded Coaches Area provides:
  - Greater separation between teams.
  - Better sightlines for table staff.
  - Improved transitions from the substitution box.
- During live play, off-field players and substitutes must stay in the Team Area until substitution is imminent.
- Substituting players should stay in the substitution box, giving the exiting player the right of way.
- Coaches must stay on the sidelines during live play.





# UNINTENTIONAL vs. INTENTIONAL CHECKS INVOLVING HEAD/NECK

- Unintentional Contact to Head/Neck: Occurs if initial force is to the body but unintentionally slides to the head/neck and shall result in a 1- minute non-releasable penalty.
- Intentional Contact to Head/Neck: Players making body checks to the body and intentionally slide up into an opponent's head/neck receive a 2 - 3 minute nonreleasable penalty.

#### **NFHS Rulebooks Corrections**

- Page 3. 5-5-h 5-4-2 Rewritten for clarity and understanding.
- Page 3. 2-1-1 Clarification for equipment issues with the goalkeeper and warm-up periods.
- Page 36 4.5.3 SITUATION A: During normal play, A1 makes a pass to A2. While the ball is in flight, B1 commits (a) a technical foul or (b) a personal foul. RULING: In (a), the official calls out "play-on," and the "play-on" is over if the pass is completed. If the pass is not completed, award the ball to Team A. In (b), Flag down, slow whistle.



#### **NFHS Rulebooks Corrections**

- Page 44 4.13.3 ART. 3... If the ball does not touch the center line or something over the center line, no infraction has occurred. A defensive player may reach over the center line with the crosse and bat the ball to keep it in the team's offensive half and thus prevent an over-and-back violation. However, that player may NOT reach over the center line and bat the ball with a foot of or any other part of the body excluding the gloved hand wrapped around the crosse. If that player does so, it shall be a turnover.
- Page 50 4.19.5 SITUATION B: Goalkeeper B1 makes a save. When out of the crease, A1 legally checks B1 back into the crease, while B1 is still in possession of the ball. RULING: Ball awarded to Team A.
